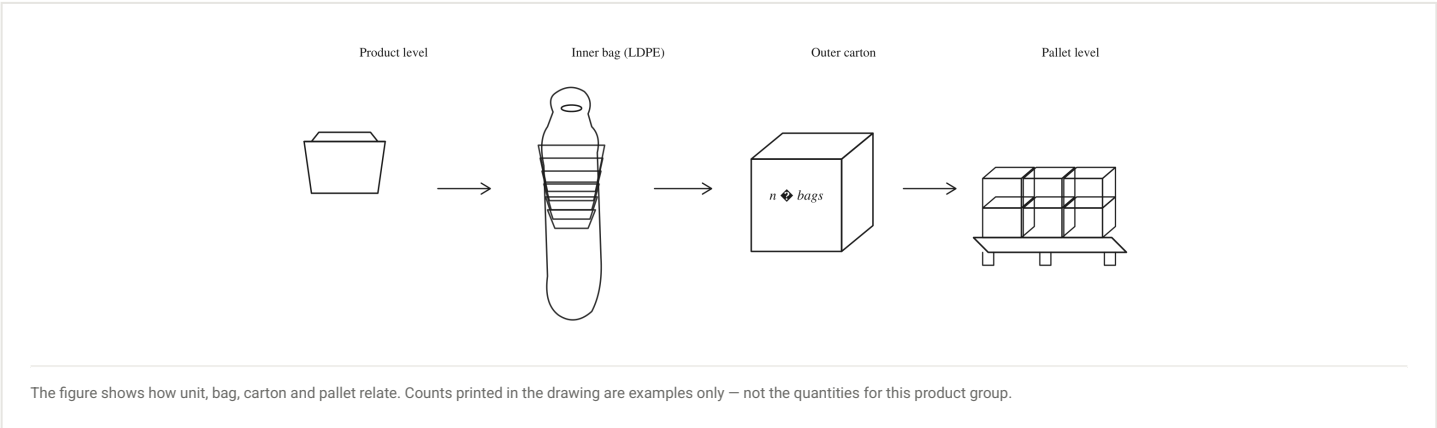
Packaging and intended use
