Transitional methodology (PPWR / PPWD): During the transitional period, recyclability and packaging minimisation continue to be demonstrated against Directive 94/62/EC (PPWD) essential requirements – typically via EN 13430:2004 (recyclability) and EN 13428:2004 (minimisation) – insofar as those routes remain applicable (PPWD-based demonstration until 31 Dec 2029). This records the interim assessment methodology pending PPWR delegated / harmonised acts; it does not postpone the Art. 6(1) and Art. 10 qualitative duties under Regulation (EU) 2025/40 from 12 Aug 2026.

7 NOTIFIED BODY

Conformity assessed under Module A – internal production control, in accordance with Article 38 and Annex VII of Regulation (EU) 2025/40. No notified body is involved in that procedure.

8 ADDITIONAL INFORMATION

8.1 APPLICABLE REQUIREMENTS – ARTICLES 5 TO 12

The manufacturer confirms, for the packaging identified above:

- Heavy metals – the sum of lead, cadmium, mercury and hexavalent chromium does not exceed 100 mg/kg.
- Restricted substances – packaging complies with applicable REACH restrictions for the intended use.
- PFAS – levels do not exceed the applicable Art. 5 limits (25 ppb / 250 ppb / 50 ppm as relevant to the material family).
- Articles 5 to 12 – fulfilment of applicable requirements is demonstrated in the Annex VII technical documentation; the internal conformity ledger is not reproduced on this form.

8.2 TECHNICAL DOCUMENTATION

The Annex VII technical documentation for this packaging type is maintained separately as a technical file (ZIP) under product group **121** (design description, material evidence and test reports). The manufacturer holds it and makes it available to market surveillance authorities on request; for container / customer-import supply it is also the primary package handed to the customer alongside this declaration. This SKU-level declaration identifies the commercial articles in points 1 and 4; the technical documentation remains organised by packaging type.

Not applicable. Conformity was assessed under Module A (internal production control) in accordance with Article 38 and Annex VII; no notified body is involved in that procedure.

8.3 RETENTION

The manufacturer shall keep this declaration and the related technical documentation for at least **5** years after the packaging has been placed on the market.
